

Registration Procedures for Turkish Scholarship (1st Placement) Students of Foreign Nationality Admitted to Ankara University for the 2025–2026 Academic Year

Registrations for students placed in Associate and Bachelor's degree programs at Ankara University under the scope of the Türkiye Scholarships (1st placement) will begin on **30 August 2025**.

Due to the registration of students under the Foreign National Quota taking place between 18–29 August 2025, the registrations of Türkiye Scholarship students cannot be taken during the specified period.

REQUIRED DOCUMENTS FOR REGISTRATION:

1. Letter of Acceptance (Invitation Letter)
2. Scholarship Commitment Form
3. Photocopy of passport and, if available, residence permit
4. For those who lost their Turkish citizenship by renunciation although they were Turkish citizens by birth, and for their descendants up to the third degree:
 - A registry record from the Blue Card Holders Register (via Mavi Kart or Identity Sharing System)
 - An official document showing identity information issued by the authorities of the current nationality
5. For dual citizens, one of whom is Turkish (acquired later): certified copy of the full individual civil registry record
6. Original secondary education (high school) diploma
7. Certified Turkish translation of the high school diploma by a sworn translator, approved by a notary or Educational Attaché
8. Original transcript and certified Turkish translation by a sworn translator, approved by a notary or Educational Attaché
9. Original certificate of equivalency issued by the Turkish Ministry of National Education or the Turkish Educational Attaché in the student's country

10. For Turkish nationals who completed their entire secondary education abroad:
 - A document from the school confirming that the entire education was completed abroad
 - or a transcript covering the entire period of study
11. For citizens of the Turkish Republic of Northern Cyprus (TRNC) who reside and completed their secondary education in the said country, and possess GCE AL exam results:
 - Or those who registered in colleges/high schools in other countries between 2005–2010 and obtained GCE AL results
 - The GCE AL result document must be approved by the TRNC Ministry of National Education
12. Three (3) recent photographs suitable for formal documents and sized 3.5×4.5 cm
13. For candidates who have been placed in Turkish-medium programs:
 - If available, a C1-level Turkish Proficiency Certificate issued by Ankara University TÖMER or Yunus Emre Institute
