## 3) ANNOUNCEMENT OF RESULTS

Student having obtained the right to register can access placements results using their e-mail and ISA number (password) at <https://ugadmissions.ankara.edu.tr/Login/Index>

## 4) DETERMINATION OF TURKISH PROFICIENCY

Candidates from abroad are required to prove their Turkish proficiency level with a Turkish Language Proficiency Certificate from Ankara University Turkish and Foreign Languages Research and Application Center (TÖMER) or Yunus Emre Institute. Those who cannot provide this document will be given a maximum of 2 years to prove their Turkish proficiency. Candidates who fail to prove their Turkish proficiency within this period will have their relationship with the University terminated.

Candidates who have graduated from secondary education institutions affiliated with the Ministry of National Education (MEB) in Turkey or abroad, those who have graduated from KKTC (Turkish Republic of Northern Cyprus) high schools and are citizens of KKTC, and

those who have graduated from KKTC high schools and are citizens of the Republic of Turkey are exempt from these requirements when applying to programs where courses are taught solely in a specific foreign language.

**After the placement processes to Ankara University are completed, candidates will be admitted to the Turkish Language Proficiency Level Exam by Ankara University Turkish and Foreign Languages Research and Application Center (TÖMER). Successful candidates eligible to receive their diplomas will start their education. Candidates who fail the exam will receive up to 2 years of Turkish language education.**

## **6) DOCUMENTS REQUIRED FOR REGISTRATION**

- 1) The original apostilled copy of the secondary (high school) education diploma and notary-certified Turkish translation by a sworn translator (Registrations will not be accepted with a temporary graduation certificate, a student certificate, or documents issued until the diploma is ready),
- 2) The original copies of transcript documents and their notary-certified Turkish translation by a sworn translator,
- 3) The original Certificate of Equivalency obtained from the Ministry of National Education's Board of Education or the Education Counselorship at the Turkish Embassy in the applicant's country,
- 4) Turkish citizens eligible to apply according to the 4th clause of the application conditions must provide a certified document showing that they completed their high school education entirely abroad. (This document must be either a certified document from the graduating school, a transcript covering the entire duration of education and an entry/exit document (to be obtained from General Directorate of Security) covering the entire duration of education)

- 5) The original exam result document constituting the basis for placement, such as TR-YÖS, Equivalent (ABITUR, International Baccalaureate, TQDK / DİM, SAT I etc.). (Applicants with GCE results who are placed must have their results certified by the Ministry of National Education in KKTC.) .
- Applicants having obtained the right to registration with SAT I are obliged to send their SAT I results to Ankara University using the 7964 code on the Collage Board System.
- 6) For KKTC citizens who completed their secondary education in KKTC and have GCE AL exam results, as well as those who enrolled in colleges and high schools in other countries between 2005-2010 and have GCE AL exam result documents. (These documents must be certified by the Ministry of National Education in KKTC.)
- 7) For those who were born Turkish citizens but renounced their citizenship via obtaining permission to leave the said citizenship, as well as those with up to the third degree of descent who are Mavi Kart (Blue Card) holders or listed in the Mavi Kartlılar Kütüğü through the Identity Sharing System, a registration sample and a document from the state authorities showing their identity information in their nationality.
- 8) For candidates holding dual citizenships, one being of the Republic of Turkey, certificate of identity registration copy with incidents is required (covering the entire the family record).
- 9) The original Ankara University Foreign Student Placement Document. (You can obtain a printout of the Ankara University Foreign Student Placement Document (Acceptance Letter) from the website <https://ugadmissions.ankara.edu.tr/Login/Index> using the email address and password you used to apply. **(Placement documents (Acceptance Letter) from other institutions, organizations, or individuals must not be deemed valid by the applicants.)**

Candidates must refer to the nearest Turkish Republic Embassy in their country with this acceptance letter to obtain a "Study Visa." This visa is mandatory for entering to Turkey and registering at the university.

- 10) Copy of passport and (for those without residency, they must bring their foreign identity number (YU number) along with their residency certificates after registration),

- 11) Six recent and biometrically taken photos sized 3.5×4.5 cm,
- 12) Receipt showing the payment of the Student Tuition Fee (information will be provided during face-to-face registration).
- 13) The financial insurance amount required for candidates having obtained the right to register to our university programs (Candidates registering must provide proof, such as a bank passbook or a commitment letter from the person undertaking to cover the costs, that they can cover the necessary expenses for completing the first year of the program, including education, accommodation, and books.) - ❖ If candidates who have obtained the right to final registration fail to submit the required documents, provide false information, or do not meet the specified criteria, their registration will be canceled, even if they have been granted the right to final registration.
- ❖ Candidates entitled to final registration (document submission) can register personally.
- ❖ Blue Card holders and Turkish citizens (excluding those who later acquired Turkish citizenship) who have been placed in Medicine, Law, Teaching, Pharmacy, and Dentistry programs are not entitled to register if it is determined that they exceed the 10% quota limitation set by the Council of Higher Education.
- ❖ Candidates who have gained the right to register in placements made within the same academic year, regardless of whether they have completed their registration, are not eligible to apply for or register through Additional Preferences under any circumstances.
- ❖ Students who are actively registered at a university in Türkiye must terminate their registration at their current university before completing registration at another university, as students are not permitted to be registered in two undergraduate or two associate degree programs concurrently.
- ❖ International students may change the university in which they are registered only once within the same academic year.
